WHY DID THE PROPERTY COUNCIL OF AUSTRALIA'S NT DIVISION LAUNCH A SURVEY?

We have witnessed over recent times the increase in Commercial Property Crime in the Northern Territory. We know that Territorians are feeling the impact this has on business and the wider community. The December 2022 statistics show that Commercial break-ins have increased across every jurisdiction year on year.

The NT Police December statistics reveal:

- 148% increase in Katherine
- 48% increase in Darwin
- 47% increase in Alice Springs
- 40% increase in Tennant Creek
- 16% increase in Nhulunbuy
- 14% increase in Palmerston

We know this is affecting the place we call home and where we operate our businesses, and that is why we conducted a survey to understand better the effects of property crime and its impact on the lives of those living in the NT.

This has allowed up to gain greater insight into the issue that will assist in the development of appropriate solutions to reduce property crime and antisocial behaviour across the whole of the NT. The survey was anonymous and sent to Property Council members and business across the Territory. We asked that one member of the business complete the survey as to not alter the data, we aimed to keep the data as accurate and clean as possible to avoid any misrepresentation.

Property Crime and anti-social behaviour: Its impacts on life in the Northern Territory.

KEY FINDINGS

Earlier this month, the Property Council of Australia - NT Division conducted a sentiment survey on the impacts of property crime and antisocial behaviour. The survey revealed that property crime, vehicle theft, and violent and threatening behaviour significantly impact businesses in the Northern Territory, with the impacts experienced by businesses and residents. Costs have been incurred through repairs and security measures. The survey was conducted anonymously and sent to Property Council members and businesses across the Territory.

Key findings from the survey indicate that 95% of respondents believe social issues and crime have worsened in the last 12 months, and 53% are considering leaving due to rising property crime. Moreover, 94% of respondents believe that crime impacts population growth, and 96% believe it affects tourism markets. A whopping 75% of respondents had been a victim of property crime, and 39% had a vehicle stolen from the premises. 70% of respondents reported that crime and antisocial behaviour had impacted their decisions to invest in property or acquire new properties.

The finding highlighted the prevalence of antisocial interaction, with 73% of businesses reporting that they were impacted by public drunkenness. Respondents commented on the types of antisocial behaviour they had experienced, including domestic violence, drug smoking, and public indecency.

The survey found 86% of respondents felt that there were not enough police resources to deal with this level of crime, with a staggering 69% of Territorians answering that they do not feel safe.


In response to the survey results, the Property Council presented a 41-page report to the Chief Minister, highlighting the need for collaborative advocacy to identify actions for improved community safety and to protect the Territory's population growth and tourism markets.

The Chief Minister acknowledged the report and advised that she would go through the data and comments with her colleagues. The findings of the survey highlight the urgent need for the government to take appropriate measures to reduce property crime and antisocial behaviour across the Northern Territory.

Thank you to the many respondents who took the time to participate in our survey. Your valuable insights will help us address the issue of property crime and antisocial behaviour in the Northern Territory. We appreciate your contribution to this important cause, and encourage you to continue to reach out with your stories, and ideas to help support this important advocacy.



WHERE IS YOUR BUSINESS OF PLACE OF WORK LOCATED IN THE TERRITORY?





DO YOU BELEIVE SOCIAL ISSUES AND CRIME HAVE WORSENED OVER THE LAST 6-12 MONTHS?




- Media reports. Have not personally experienced crime, although a friend was bag snatched recently in Katherine.



HOW MUCH (APPROX) HAVE YOU SPENT ON REPAIRS OR DAMAGES?








HAVE YOU HAD A VEHICLE STOLEN OR DAMAGED FROM YOUR BUSINESS PREMISES?




- It directly impacts our ability to attract brands to the NT.


- Anti social behaviour whilst hanging around our premises which makes it highly unpleasant for our customers to be subjected to this in order to gain access to our staff and premises
- Sitting in access doorways to premises
- Theft
- Smoking weed and excessive drinking to the point where they argue and fight
- Threats, drunkenness, aggression, abuse, violence and walking around with edged or other weapons
- damage to property
- Litter, rotten food, maggots
- Groups of children as young as 7-15 roam around our business, sleeping rough nearby & come into our shop asking for food and water - Have reported this many times. Groups of drunken adults walk past and come into the shop asking for food and money, they hang around our shop and fight, they curse at us when we ask them to leave. They leave rubbish all over the place that we have to clean up. They like to set up camp near our business, we never feel safe leaving to go home and have to get someone to walk us to our cars. So far I have had to lock myself, staff and customers in the shop 8 times now, to protect ourselves from groups of adults & kids that are either fighting each other or because they have threatened us directly.

OTHER CONTINUED...

- Food taken from customers plates. Customer harassment. Refusal to leave the premises.
- Broken front windows, unlawful entry into property on many occasions, intimidation towards staff, theft from reception desk, untidy rubbish including alcohol bottles and food left outside premises most days
- public masturbation
- I had a threat on my life douse me in fuel and set alight
- coming in & sleeping on the floor, repeatedly kicking out sandwich board to the curb & damaging it.
- Lots of abusive writing on the walls including F the police.
- Litter
- Alcohol on the streets
- vandalism
- Fights, property damage, theft
- intimidating behaviour not necessarily targeted at me
- Graffiti, public intoxication
- Graffiti
- Being racially abused with obscene language
- Rough sleepers and drinkers.
- Racial taunts
- rubbish from squatting and drinking on the land and leaving rubbish and broken glass behind almost daily
- Our staff feel are impacted because it's quite confronting and emotionally conflicting for them. On the one hand our team tend to be progressive in their social views but increasingly it impacts how they live their life day to day and their work life. Also the incidents that they have witnessed which involve public violence often against women is traumatic,
- Sleeping on external entrances to premises, nudity, public sex acts, rubbish, broken wine bottles.

DO YOU BELIEVE THERE ARE ENOUGH POLICE OFFICERS IN THE Northern territory to deal with high levels of anti-social Behaviour and crime?



- Adopting a systematic approach to identify opportunities for restorative justice. In my experience police don't know of/think of this approach unless requested by the 'victim'.
- I do not have enough information to make an educated answer.
- it is very hard for police to try and manage all of this
- The police need to be allowed to deal with the problem and sentencing them.
- My son is a copper, he's nearly burnt out at 37 yrs old.
- Even if there is, they are not doing enough from preventing the crimes from happening again and again.
- No but why would people want to join the police force to be thrown under a BUS for doing their jobs
- Not sure of total numbers where they are based or their roles being front line or administrative
- By the time they are reported and police arrive, they are usually gone from the area
- More police needed but only if the law makers support the law enforcers
- Yes I do. I just wish they were patrolling on foot more and actually showing their presence. What ever happened to cops patrolling a beat?
- The police are limited in their powers
- Its not a police problem its a social problem





- not immediately but this may be a factor in the future as I have small children
- yes. I want to feel a lot safer then I do
- essential public service, cannot leave
- Perhaps, at the moment i am neutral
- In the process of getting organised to sell & leave
- not quite but if it continues or gets worse it is probable. it is not just the damage it is the stress of receiving phone calls from security monitoring in the middle of night and having to leave phone on to receive those calls.
- Sometimes I think about leaving as I feel scared a lot and I am very worried about raising my children here.
- We want our freedom back


DO YOU BELIEVE THAT CRIME IS HAVING AN IMPACT ON OUR POPULATION GROWTH?

- Why would people want to come to the NT where you just see drunks everywhere.


DO YOU BELIEVE THAT CRIME IS HAVING AN IMPACT ON OUR TOURISM MARKETS?








Federal intervention.

LASTLY, DO YOU CURRENTLY FEEL SAFE?



- Mostly
- I was attacked from behind in the city by a drunk indigenous male
- Not in shopping centres and walking at night
- Currently yes but too often not
- Not always
- Always aware of surroundings and locking doors and security doors when home alone.
- Reasonably
- I personally feel safe, but I am very concerned about the security of my business
- Most times, but keep awareness out when in Alice Springs. Have to change my behaviour when going out compared to a couple of years ago i.e. parking, where I go at night, no longer go out on walking trails without company. Very frustrating.
- I know where not to go I know where I feel safe
- Not at all times. Not in particular areas
- Only in the past 6 months I do not feel safe at all
- Obviously not , and now they know who I am.
- Depends. I am more mindful of where we go
- Locked in my own home after dark is not living
- Depends on where I am -- I also do not attend casuarina shopping centre. Will move bank because it is in the shopping centre
- Not at all the elderly and most vulnerable are sick of it no one feels safe
- In the past few months I have started locking my car doors when I am driving
- No I feel very unsafe and worry also for clients coming into my shop
- Because I attended a personal safety course. I feel as safe as it is possible to be considering the crimes bring perpetrated
- I have dog's
- There are times when you feel unsafe, but generally yes. My wife was confronted by a group in the basement carpark of our building only last week.
- Personally yes, my car/house/belongings no
- I do, but my wife doesn't if I'm away she locks gate and has little sleep
- Only because I live in the rural area. People in many other parts of the territory are being terrorised
- Not unsafe but less safe than 10 years ago
- no, the type of crime and the risk of violence if you see and confront has escalated dramatically. A sharp word used to discourage, not anymore
- Yes I feel safe because I am a male. If I was a female I would not feel safe at all. However, even as a bloke I feel a bit confronted when I groups of people who are clearly drunk and yelling and screaming at each other and random people. Just a few weeks ago I walked into a restaurant in Darwin CBD in early evening and still light and a person followed me from my car to the door of the venue swearing
- not completely. I wouldn't have my kids alone at a playground or shops
