

## Award for Best Revitalisation

### Award overview

This Award recognises an outstanding refurbishment in retirement living.

A refurbishment can relate to units and/or community facilities such as dining areas, library, swimming pool, croquet lawn, etc which have undergone minor or large refurbishment.

Eligible entrants will be projects that have been completed in the previous five years, have been operating for at least one year as of 30 June 2024 and have not previously won the Award.

The award is open to members of the Property Council of Australia only. Innovation in the responses should be clearly expressed.

### Key dates

- Nominations close: 15 November 2024
- Inspections – in person for all entries: 10 to 28 February 2025
- National finalists announced: 13 March 2025
- National winners announced: 19 June 2025, Brisbane

### Judging criteria

Each entry is assessed against the following criteria by a panel of independent judges.

The criteria aligns with the [Liveable Housing Australia Design Guidelines](#) and [The Property Council's Best Practice Principles for Seniors Community Design](#).

Criteria	Weighting
<b>Refurbishment</b> (200 words maximum)  Provide an overview of the village including the number of residents, average age of residents, age of the village, number of units/apartments and/or types of services/housing available.  Describe, using specific examples, the ways in which the development displays excellence in refurbishment. This can be achieved through highlighting great design practice, choice of products or new construction procedures which provide minimal disruption and great results for residents and staff, resident satisfaction and sales enquiries/occupancy.	<b>25%</b>

<p><b>Corporate social responsibility</b> (200 words maximum)</p> <p>Describe how the refurbishment demonstrates tangible economic, environmental and social dividends.</p>	15%
<p><b>Quality of design and finish</b> (200 words maximum)</p> <p>Give details explaining the ways in which the development exhibits a <b>luxury</b> quality of architectural design; is compatible with surrounding land uses and contributed to the success of the development project (e.g. site constraints, unique design solutions, and project cost constraints). <b>Supply supporting images.</b></p>	10%
<p><b>Resident satisfaction of village facilities</b> (200 words maximum)</p> <p>Describe, using testimonials from a variety of stakeholders, what benefits were delivered by the refurbishment and the impact on resident satisfaction.</p>	25%
<p><b>Industry/community perception</b> (200 words maximum)</p> <p>Describe, using testimonials from a variety of stakeholders, the extent to which the refurbishment is considered a success by the retirement living industry.</p>	15%
<p><b>Best practice design guidelines</b> (200 words maximum)</p> <p>Explain to what extent the nominated project aligns with the Liveable Housing Australia Design Guidelines. It is not necessary for the project to have obtained certification of a performance level.</p> <p>Provide examples which show this alignment.</p> <p>If the project does not align with the Guidelines, please explain why the Guidelines are not applicable or appropriate for the project.</p>	5%
<p><b>Best practice principles</b> (200 words maximum)</p> <p>Explain to what extent the nominated project aligns with the Property Council's Best Practice Principles for Seniors Community Design.</p> <p>Provide design examples which show this alignment.</p> <p>If the project does not align with the Principles, please explain why the Principles are not applicable or appropriate for the project.</p>	5%

To assist the organiser in promoting the nomination within the awards marketing material, a summary of the entry of no more than 80 words should be provided.

### Entry photos

Supporting images are required to be submitted with the online submission before the nomination deadline. Please upload a maximum of 6 images (minimum of 4 images is mandatory). These images should be used to support the **Quality of Design and Finish** criteria.

#### Image requirements:

- landscape format
- jpg, png or .eps format
- high resolution (300dpi)
- minimum 1920px
- maximum file size of 5MB each

Additional supporting information, such as video links, village fact sheets, written testimonials, etc., may also be uploaded along with the required images.

**Hero Image** – If there is a preferred image to represent the project throughout the Awards Program, please label this as “Hero Image” before uploading (the Hero Image should be landscape if possible and a min file size of 4MB).

### People’s Choice Award

Projects entering this award will be eligible for the **People’s Choice Award for Best Retirement Community**. Voting is via our online voting poll which opens from **23 April to 21 May 2025**.

Please provide a hero image and confirm the village name as part of the online submission.

- Eligible entries will be projects that have been completed in the previous five years as of 30 June 2024 and have not previously won the Award
- Nominating companies must be a Property Council of Australia member

- Before you submit your nomination, ensure you have permission from the owner, your client or your contractor to do so
- All entries must be submitted via the online nomination form
- Entries must stick to the word limit on the online nomination form. Nominees are reminded that judges will not consider formatting or presentation of entries
- Nominees must include 4-6 images to support their submission. Other material relevant to support the application may also be uploaded as an Appendix in .pdf format only
- All nominees should be prepared to attend a site inspection with a judge, should it be deemed necessary
- All nominations and contents will remain the property of the Property Council of Australia
- Please note entries are exclusive to the Property Council of Australia National Retirement Living Awards and no details private or professional will be distributed to outside contacts
- The judge's decision is final and no communication will be entered into concerning the final decision
- The Property Council of Australia reserves the right to publish the results and winner details
- The finalists should be available to attend the National Retirement Living Awards Gala Dinner to be held in Brisbane on Thursday, 19 June 2024
